CALL FOR 2021 AWARD NOMINATIONS

The IOMC Award for Public Service

Presented to a Chicago, Cook, and Collar Counties area healthcare professional who has a longstanding history of highly valuable public service on a voluntary basis. Such service should have enhanced the health of residents of the Chicago, Cook, Collar County area. The healthcare professional need not be a Fellow of the IOMC.

The IOMC Humanitarian Global Health Award

Presented to a Chicago, Cook, and Collar Counties area individual or organization that has provided voluntary, longstanding, and international humanitarian health service(s). The recipient need not be a Fellow or affiliated with the IOMC.

The Portes/IOMC Award for Excellence in Prevention of Disease Award

Awarded periodically to an individual in the Illinois region who has shown excellence in health promotion and disease prevention by their contributions in the area of prevention of disease, and the remediation of disability and human suffering. The individual need not be a Fellow of the IOMC.

Innovation in Health Care/Health Care Delivery Award

The Innovations in Health Care/Health Care Delivery Award recognizes an individual or organization that has implemented an approach, strategy or improvement in health care or health care delivery that enhances patient care, equity and/or improves outcomes. The healthcare professional need not be a Fellow of the IOMC.

Lifetime Achievement Award

The Lifetime Achievement Award is a rare recognition provided by the Institute to an individual whose contributions, meaning and significance to the Institute cannot be expressed in any other way. Acknowledges an individual and a career as a healthcare leader and abiding commitment to the welfare of patients and health of the citizens of Chicago or State of Illinois.

The Nomination Process

The 2021 Annual Meeting will be held on Friday, June 25, 2021, a virtual meeting. The nominee must be able to attend the Annual Meeting -virtual/video award presentation.

Nominations for the above awards are solicited from local healthcare and non-profit organizations and from the membership of The Institute of Medicine of Chicago.

An individual or organization may submit more than one candidate nomination.

The Institute of Medicine of Chicago has formed a committee to conduct the selection process and propose final candidates to the IOMC Board of Governors. The final 2021 award recipient(s) will be presented at the Annual Meeting of The Institute of Medicine of Chicago. *All nominations will be kept confidential by those involved in the selection process.*

The Institute of Medicine of Chicago is a non-profit organization whose primary purpose is to promote the study and advancement of health sciences and their application to human needs.

- The curriculum vitae or resume of your candidate.
- List three individuals who will support the nomination. Please include full address and contact information should the committee wish to contact them.

Statement of Nomination

Your nomination letter should be no longer than three pages and should include each of the following sections:

- **Description of the Candidate:** A detailed explanation of why your candidate should be considered for the Citation. This should include details of the proposed candidate's exemplary humanitarian activities; a personal history including evidence of participation beyond the job-volunteer activities/community and civil service; personal involvement with elements such as students, patients, colleagues, the public, etc.; and examples of dedicated lifetime personal and career experiences.
- **Examples:** Specific achievements that indicate an extraordinarily compassionate and humanitarian approach towards healthcare.
- **Candidate's Impact on Profession:** A description of the impact your candidates' humanitarianism has had on the profession or community in which he or she has been active.
- **Influence:** A description of ways in which your candidate's work has had an influence on the community beyond his or her own professional sphere.
