CALL FOR 2023 AWARD NOMINATIONS

The IOMC Humanitarian Global Health Award

Presented to a Chicago, Cook and Collar counties area individual or organization that has provided voluntary, longstanding, and international humanitarian health service(s). The humanitarian work must be performed outside of the US. The history and timeline of the work initiatives must be included in the submittal. The recipient need not be a Fellow or affiliated with the IOMC. Deadline May 1, 2023

The Portes/IOMC Award for Excellence in Prevention of Disease

Awarded periodically to an individual in the Illinois region who has shown excellence in health promotion and disease prevention by their contributions in prevention of disease, and the remediation of disability and human suffering. The individual need not be a Fellow of the IOMC. Deadline May 1, 2023

IOMC Innovation in Health Care/Delivery Award

The Innovations in Health Care/Health Care Delivery Awards recognizes an individual or organization that has implemented an approach, strategy or improvement in health care or health care delivery that enhances patient care, equity and/or improves outcomes. Two awards comprise this specific award. 1) Health Improvement - academic institutions. 2) Healthcare Delivery - individual or an organization. A curriculum vitae of the leader must be submitted if the nomination is an organization. The healthcare professional need not be a Fellow of the IOMC. Deadline May 1, 2023

IOMC Award for Public Service

Presented to a Chicago, Cook and Collar counties area healthcare professional who has a longstanding history of highly valuable public service on a voluntary basis. Such service should have enhanced the health of residents of the Chicago, Cook and Collar counties area. The healthcare professional need not be a Fellow of the IOMC. Deadline May 1, 2023

IOMC Lifetime Achievement Award

The Lifetime Achievement Award is a rare recognition provided by the Institute to an individual whose contributions, meaning and significance to the Institute cannot be expressed in any other way. Acknowledges an individual and a career as a healthcare leader and abiding commitment to the welfare of patients and health of the citizens of Chicago, Cook, Collar Counties and the State of Illinois. Deadline May 1, 2023

These awards will be presented at the Annual Meeting, if awarded.

The Nomination Process

Nominations for the above awards are solicited from local healthcare and non-profit organizations and from the membership of the Institute of Medicine of Chicago.

An individual or organization may submit more than one candidate nomination. Submit a curriculum vitae of the leader of initiative, if an organizational submittal.

The Institute of Medicine of Chicago has formed a committee to conduct the selection process and propose final candidates to the IOMC Board of Governors. *All nominations will be kept confidential by those involved in the selection process.*

The Institute of Medicine of Chicago is an independent non-profit organization whose primary purpose is to promote the study and advancement of health sciences and their application to human needs.

The Institute provides educational programs and publications, conducts studies, and promotes educational and service directions in health care for the benefit of the Chicago, Cook, Collar Counties and the State of Illinois community.

Statement of Nomination Your nomination letter should be no longer than three pages and should include each of the following sections:

Description of the Candidate: A detailed explanation of why your candidate should be considered for the Award. This should include details of the proposed candidate's exemplary humanitarian activities; a personal history including evidence of participation beyond the job-volunteer activities/community and civil service; personal involvement with elements such as students, patients, colleagues, the public, etc.; and examples of dedicated lifetime personal and career experiences. Please submit a curriculum vitae of the candidate. If submitting an organization, please include the curriculum vitae of the leader of the initiative.

Examples: Specific achievements that indicate an extraordinarily compassionate and humanitarian approach towards healthcare.

Candidate's Impact on Profession: A description of the impact your candidates' humanitarianism has had on the profession or community in which he or she has been active.

Influence: A description of ways the candidate's work has had an influence on the community beyond his or her own professional sphere.

Nomination material must be submitted in single PDF. All materials must be properly completed and submitted to be eligible.
